## 100% Cashless Treatment across the Country

**Context:** General and health insurance providers are elevating the health insurance sector by introducing a nationwide 100% cashless treatment initiative starting January 25th.

#### Overview of the Initiative:

- The Insurance Regulatory and Development Authority of India (IRDAI) has initiated a significant step in the health insurance sector.
- The move aims to introduce 100% cashless treatment across the country, starting from January 25.

#### Objectives and Impact:

- Expected to boost insurance penetration in India.
- Aims to streamline and expedite the claim process for policyholders and hospitals, reducing delays and disputes common in reimbursement methods.

#### Working of 100% Cashless Treatment:

- Under the 'Cashless Everywhere' system, policyholders can receive treatment in any hospital without making any upfront payments.
- Cashless facility is available even if the chosen hospital is not in the insurance company's network.
- The policyholder is not required to pay any advance money; the insurance company settles the bill on the discharge day.

#### Procedure and Guidelines:

- Policyholders need to inform the insurance company at least 48 hours before admission.
- In case of emergency treatment, the insurance company should be notified within 48 hours of admission.
- Claims should adhere to policy terms, and cashless facility eligibility follows the operating guidelines of the insurance company.

#### Technological Support:

- The 100% cashless system is supported by a technological platform, aided by the National Health Authority.
- Standardization of rates and services is crucial for the successful implementation of the new cashless payment system.

#### Current Scenario:

- As of the fiscal year 2022-23, 56% of health claims were settled through the cashless route, according to the IRDAI Annual Report.
- Cashless facility is currently available only at hospitals with agreements or tie-ups with the insurance company.



#### > Expected Benefits and Stakeholder Perspectives:

 The 100% cashless system is seen as a win-win for hospitals, policyholders, and insurers.

- Anticipated increase in health insurance uptake due to ease of claims settlement.
- Potential reduction in fraud, enhancing trust in the insurance system.
- **Claim Settlement Statistics:**
- During 2022-23, insurers settled 2.36 crore health insurance claims, paying Rs 70,930 crore.
- The average amount paid per claim was Rs 30,087, with 56% settled through cashless mode and 42% through reimbursement mode.
- Future Outlook: The health insurance segment is expected to surpass the Rs one lakh crore mark in premium mobilization during fiscal 2023-24, with Rs 79,559 crore mobilized in the nine-month period ending December 2023.

## 'Sapinda' Marriages

**Context:** The Delhi High Court rejected a challenge to the constitutionality of Section 5(v) of the Hindu Marriage Act, which prohibits marriage between two Hindus if they are "sapindas" unless their custom permits it.

- Definition of Sapinda Marriage:
  - Sapinda marriage involves individuals related within a specified degree of closeness, as defined in Section 3 of the HMA.
  - Sapindas are individuals sharing a common lineal ascendant within the limits of sapinda relationship.

#### Prohibitions under Section 5(v):

- On the mother's side, a Hindu individual cannot marry within three generations of their line of ascent.
- On the father's side, the prohibition extends to individuals within five generations of the individual.

#### Void Marriage and Exceptions:

- Violation of Section 5(v) for sapinda marriage without established custom results in the marriage being declared void.
- Exception: Custom permitting sapinda marriages, defined in Section 3(a) of the HMA, must be continuously observed, gaining legitimacy as per certain conditions.

#### Challenges and Grounds for Law Challenge:

- In 2007, a woman's marriage was declared void for sapinda relationship without proof of custom.
- The petitioner challenged the constitutional validity of Section 5(v), arguing a violation of the right to equality under Article 14.
- Claimed prevalence of sapinda marriages without proof of custom and cited family consent as proof of legitimacy.

#### Court's Ruling and Reasoning:

- The Delhi HC found no merit in the petitioner's arguments.
- Lack of stringent proof of an established custom to justify sapinda marriage.
- Court emphasized the regulation of partner choice in marriage, rejecting claims of a violation of the right to equality.

#### International Perspective on Incestuous Marriages:

- In European countries like France, Belgium, and Portugal, laws on incestuous relationships are less stringent.
- Republic of Ireland recognizes same-sex marriages but has not updated laws on incest.
- Italian law criminalizes incest only if it causes a "public scandal."

 In the United States, incestuous marriages are banned in all 50 states, except in New Jersey and Rhode Island for consenting adults.

## **India-France Relations**

**Context:** On this Republic Day, French President Emmunel Macron was invited as the chief guest for the ceremony.

### History of India-France Relations:

#### • Post India's Independence:

- Diplomatic ties were established after India gained independence.
- Indian air fleet integrated French aircraft and helicopters since the 1960s.
- France supplied nuclear fuel to the Tarapur power plant in 1984 after the U.S. withdrew support.

#### • Post Cold War Era:

- India and France entered into a Strategic Partnership in 1998.
- Principal pillars include defense, security, space, and civil nuclear cooperation.

#### > Areas of Cooperation Between India and France:

#### • Geo-Political:

- France supported India's UNSC membership and reforms in the United Nations.
- Key support for India's accession to MTCR, Wassenaar Arrangement, and Australia Group.
- France invited as the Republic Day chief guest multiple times.

#### • Geo-Strategic:

- France offered strategic assets in the Indo-Pacific, deploying Indian Air Force planes to Reunion Island.
- France part of the India-France-Australia Trilateral Dialogue for an inclusive Indo-Pacific.

#### • Defense and Security:

- France is a key defense partner, supplying Rafale and Mirage 2000 fighter aircraft and Scorpene submarines.
- Joint military exercises like Varuna, Garuda, and Shakti.
- Joint patrolling in the Indian Ocean Region, enhancing maritime domain awareness.

#### Economic Cooperation:

- Bilateral trade reached USD 13.4 billion in 2022-23, with France as the 11th largest foreign investor in India.
- Over 1,000 French establishments in India, employing around 300,000 individuals.

#### • Energy and Climate:

- French support crucial for India's exemption from the NSG in 2008 and active backing for India's NSG entry.
- Significant roles played in establishing the International Solar Alliance.

#### • Science and Technology:

- Collaboration on space missions, including Joint Earth Observation Mission and Mars Mission.
- Joint construction of the world's largest nuclear park in Jaitapur, Maharashtra.
- **Diaspora**: Around 109,000 Indians in France, with significant Indian-origin populations in French Overseas Territories.



#### Significance of India-France Relations:

- Securing the Indo-Pacific: Crucial for maintaining stability and countering Chinese aggression in the Indo-Pacific.
- Strategic Autonomy: Not constrained by Anglo-Saxon views or anti-western sentiments, maintaining strategic autonomy.
- Entry to Key Organizations: France's support crucial for India's entry into organizations like the UNSC and NSG.
- Global Stability: Essential for checking Russia's assertiveness in Europe and countering China's assertiveness in Asia.
- Horizon 2047 Agreement: Lays down the future roadmap of collaboration in emerging domains like supercomputing and artificial intelligence.

#### Challenges in India-France Relationship:

- Absence of Free Trade Agreement: Lack of an FTA impacting deepening economic relations.
- Trade Imbalances and IPR Issues: Trade imbalances and concerns over intellectual property rights protection.
- **Stalled Projects:** Non-operationalization of negotiated projects, such as the Jaitapur nuclear project.
- **Differences in Geopolitical Approaches:** Varied stances on geopolitical issues like Russia's invasion of Ukraine and China's BRI.
- Emerging Geopolitical Scenario: Disturbances in the Middle East and uncertainties in the global geopolitical landscape.

Gallantry Award	<ul> <li>Recently, the President of India has approved gallantry awards to 80 military personnel, including 12 posthumous, for the 75th Republic Day.</li> <li>Gallantry Award: <ul> <li>A Gallantry Award is a prestigious award given to police officers in India for displaying bravery, courage and devotion to duty.</li> <li>This award is announced twice a year, first on the occasion of the Republic Day and then on the occasion of Independence Day.</li> <li>It is classified into two categories: gallantry in the face of the enemy and gallantry other than in the face of the enemy.</li> <li>The first category of the award comprises the Param Vir Chakra (PVC), Mahavir Chakra (MVC) and Vir Chakra.</li> <li>The second category comprises the Ashok Chakra, Kirti Chakra and Shaurya Chakra.</li> <li>The Ashoka Chakra is the highest peacetime Gallantry Award and given for courageous action, valour or self-sacrifice away from the battlefield.</li> <li>The Kirti Chakra is the second-highest peacetime Gallantry Award and the Shaurya Chakra is the third-highest.</li> </ul> </li> </ul>
