## Star ratings for State Environment Bodies

DHYEYA IAS most trusted since 2003

**Context:** The Environment Ministry's plan for a star-rating system to assess states' efficiency in granting environmental clearances hasn't been put into action, as confirmed by the Ministry to the National Green Tribunal (NGT).

#### Introduction of Star-Rating System:

- The Ministry introduced a star-rating system in January 2022.
- The system was challenged in the NGT by Meenava Thanthai K R Selvaraj Kumar Meenavar Nala Sangam, a Tamil Nadu-based organization advocating for fishermen's rights.

#### **Objective:**

- The primary objective is to enhance the ease of doing business in India.
- This initiative was formulated during a meeting of cabinet secretaries held in the year 2021.
- The overarching goal is to expedite and simplify the environmental clearance process across the country.

#### Assessment Criteria:

- 1. Proposals pending for more than thirty days will be assessed.
- 2. Additionally, the evaluation will consider pending proposals for Terms of Reference for over 30 days.
- 3. The system will measure the percentage of new Terms of Reference disposed of within the last six months.
- 4. Evaluation will also focus on the number of environmental clearances pending for over 105 days.
- 5. Reassessment of complaints will be factored into the assessment criteria.
- 6. Furthermore, the number of site visits conducted by the authorities will be taken into account during the evaluation process.

#### System Implementation Details:

- The ranking system was established following a meeting chaired by Cabinet Secretary Rajiv Gauba in November 2021, focusing on promoting 'ease of doing business.'
- SEIAAs grant clearances based on recommendations from Expert Appraisal Committees, which assess project proposals with significant environmental impacts.
- Under the star-rating system, SEIAAs earn points on a scale of 0 to 7 based on clearance timelines:
- Two points for clearances granted in less than 80 days.
- One point for clearances between 80 and 105 days.
- 0.5 points for clearances between 105 and 120 days.
- Zero points if clearance takes more than 120 days.

#### How does it hamper EIA?

- Insufficient independent environmental experts within State committees currently leave decision-making to bureaucrats, potentially sidelining environmental concerns for economic gains.
- The Legal Initiative for Forest on Environment (LIFE) opposes the scheme, citing violations of the Environment (Protection) Act.

- The proposal reduces State Environment Impact Assessment Authorities (SEIAAs) to rubber stamp authorities, undermining their mandate for detailed scrutiny.
- It weakens regulatory oversight crucial for environmental protection, as highlighted in Supreme Court verdicts safeguarding the right to life.
- Implementation risks fostering unhealthy competition among states to expedite project clearances, potentially compromising thorough environmental assessments.

#### **Trademarks Act, 1999**

**Context:** The Delhi High Court cancelled Mohammed Akram Khan's trademark registration for "Dolma Aunty Momos" after Dolma Tsering objected to its unauthorized use.

#### Trademark:

- A trademark, whether a symbol, design, word, or phrase, serves as a distinctive identifier for a business.
- Registering a trademark grants its owner exclusive rights to its usage.
- The Trademarks Act of 1999 governs trademarks and their registration in India, overseen by the Controller General of Patents, Designs, and Trademarks.
- Section 25 of the 1999 Act stipulates that a registered trademark remains valid for 10 years and can be renewed periodically by the owner.
- Unauthorized use of a registered trademark constitutes infringement, as does using a substantially similar mark for similar goods or services.
- Trademark infringement can occur in various ways, as evidenced by cases like the Dolma Aunty matter.

#### Trademark Law Before 1940:

- Prior to 1940, India lacked specific trademark legislation.
- Issues of trademark infringement were addressed under Section 54 of the Specific Relief Act, 1877, and registration was adjudicated under the Indian Registration Act, 1908.

#### Trademark and Merchandise Act, 1958:

- The Trademark and Merchandise Act, 1958 replaced the previous law.
- It aimed to provide better protection against fraudulent use of marks on merchandise and facilitated trademark registration for exclusive use.

#### Trademark Act, 1999

- The government of India replaced the 1958 Act with the Trademark Act, 1999.
- This transition aligned with TRIPS obligations recommended by the World Trade Organization.
- The Trademark Act, 1999 aims to protect trademark users and regulate property conditions.
- It provides legal remedies for enforcing trademark rights.
- The Trademark Act, 1999 empowers authorities to arrest individuals involved in trademark infringement.
- The Act specifies punishments and penalties for offenders.



#### **Types of Trademarks**

#### Product Mark:

- Used on goods or products to identify their origin.
- Helps in maintaining the reputation of a business.
- Trademark applications filed under trademark class 1-34 represent goods.

#### Service Mark:

- Used to represent services rather than products.
- Distinguishes its proprietors from owners of other services.
- Trademark applications filed under trademark class 35-45 represent services.

#### **Collective Mark:**

- Used to inform the public about distinguished features of a product or service representing a collective.
- Held by an association, public institution, or Section 8 Company.
- Standards of products fixed by the regulator owning the mark.
- Others associated with the collective adhere to certain standards while using the mark.

#### Certification Mark:

- Denotes a product's origin, material, quality, or specific details issued by the proprietor.
- Ensures the standard and quality of the product to customers.
- Used to uplift the product's standard among customers through standard tests.

#### Shape Mark:

- Protects the shape of a product, making it relatable to a certain manufacturer.
- Examples include Coca-Cola and Fanta bottles with distinctive shapes identifiable with the brand.

#### Pattern Mark:

- Products with specific designed patterns serving as distinguishing factors.
- Patterns must show evidence of uniqueness to be registered.

#### Sound Mark:

- Sound associated with a product or service originating from a specific supplier.
- Sound marks easily identify the product, service, or show.
- Popular examples include sound logos at the beginning or end of commercials, such as the IPL tune in India.

### Joint Logistics Over-the-Shore (JLOTS)

**Context:** Ships from the US Army departed from Virginia carrying equipment to construct a floating pier off the Gaza coast, facilitating the delivery of humanitarian aid to the region. > JLOTS Military Project:\*

• JLOTS is a military project initiated by the US Department of Defense.

#### **Objective:**

• The main objective of JLOTS is to enhance the military's logistics capacity in regions lacking adequate fixed port facilities.

#### Operational Features:

- These operations involve collaboration among various military branches.
- The navy handles transportation and security of goods, while the army or other agencies manage tasks such as infrastructure construction and delivery.
- Specialized equipment like floating causeways and barges are utilized to move cargo between ships and shore, even in challenging areas.

#### Significance:

- JLOTS is particularly valuable during humanitarian and disaster relief efforts, ensuring swift delivery of aid.
- The US military has previously utilized JLOTS in Kuwait, Somalia, Haiti, and Central America for disaster relief missions.


#### JLOTS in Gaza:

- The construction of the floating pier in Gaza will not involve direct US military participation.
- Collaboration with Fogbow, a private company led by former military and intelligence personnel, will facilitate the project.

#### **Components:**

- The project comprises two main parts: a floating dock and a 548-meter-long pier with a causeway.
- The steel floating dock will be transported by a roll-on, roll-off ship designed for heavy cargo.
- The pier, connected to the shore, will feature a causeway extension to prevent vehicles transporting aid from getting stuck in soft sand.

JLOTS, the US Army's temporary port system This system (Joint Logistics Over-the-Shore) makes it possible to set up a link between large ships and the coast in a matter of weeks, in places like the Gaza Strip
